# THE PARK RANCH DUCK CLUB RULES OF CONDUCT

Park Ranch Duck Club is a permit issuing property. This means that we have already determined the rules and regulations and permit holders will not have a voting voice in the rules. You're cost of a permit will earn you a permit to hunt. Permit holders (PH) that pay their dues are agreeing that they have read and understood this rule book, and agree to abide by these rules within it. Permit Holders must carry their Permit ID on their person at all times when on property. Failure to do so will result in a revocation of their permit WITHOUT a refund of dues.

The rules of the Park Ranch Duck Club are to be adhered to at all times by members and their families. Members shall be completely responsible for the activities of their family members.

#### 1. Meeting Attendance

- 1. Permit Holders must attend at least one (1) of the three (3) meetings regularly scheduled each year. At location determined by Club owner.
- **2. Permit Dues:** All Dues must be paid August 1<sup>st</sup> or late fees will accrue (\$100/month)
  - 1. Initial Permit Holder: \$500.00/person (Initiation Fee)
  - 2. \$3,500/ year/permit holder
  - **3**. Additional Family Members (Maximum 3)
  - \*16-18 Years old: \$400
  - \*19-21 Years old: \$600

## \*ALL ADDITIONAL FAMILY MEMBERS MUST BE ACCOMPANIED BY PERMIT HOLDER OF CLUB\*

#### 4. Ranch/Property Conditions

- 1. Trash Haul out everything you bring in, leave the ranch in the condition you found it (or better!). Pick up **ALL** empty shell casings before leaving the area.
- **2.** Gates Leave the gates in the condition you found them.
- **3.** Fences Do not climb over, alter or otherwise disturb any fence.
- **4.** Driving Take care when driving, stay on roads and alternate routes (no driving off any roads). When raining, ATV's are permitted on alternate roads, no vehicles on side routes if mud is present, helmets are required at all times when operating ATV's.
- **5.** Parking When hunting on property, Permit Holders are required to park in the designated areas with evidence of permit on dashboard.

- **6.** Irrigation Devices Do not modify any irrigation device in any way. If something appears to be functioning incorrectly, contact Chris Passas (775) 267-9897
- 7. Livestock Do not alarm, molest or discharge a firearm near any livestock.

#### 5. Hunting Days on Park Ranch Duck Club

- 1. The Topaz property (Park Livestock Ranch) and the Minden Property (Park Ranch LLC) may be hunted Saturday, Sunday, and Wednesday from opening day until close of the season. Holidays included
- 2. You may hunt the following holidays in the current year:
- a) New Years Day
- b) Martin Luther King Jr. Day
- c) Thanksgiving
- d) Christmas

#### 6. Hunting Etiquette

- 1. No permit holder or their family should knowingly take any action that will disturb the hunting experience of any other permit holder.
- **2.** All hunters will abide by all federal and state hunting regulations.
- 3. If you hunt the MORNING AND/OR EVENING and you leave the area that you were hunting, pull your decoys out of the water (or off the field) before you leave. If, in fact, your decoys are left, understand that they do not hold the hunting spot for you.

#### 7. Blinds and Blind Maintenance

- **1.** Blinds shall be built only after notifying the club owner of the date he permits you to.
- 2. Non-permanent or damaged blinds as well as all material used to build them shall be removed within two (2) weeks of the close of the season unless authorized by Club owner.
- **3.** Permit holder has received a blinds and blind maintenance form which details further regulations and maintenance requirements.

#### 8. Infractions

- 1. Infractions of the Club's rules and/or by laws will be investigated by the Club owner and affiliates. Ramifications of infractions are determined by club owner ranging from:
  - \* Levee a fine against the offending member, which must be paid prior to their hunting any Club property.
    - \* Revoke the membership of the offending member without refund.
